# History of the Greenpoint Project




### **Greenpoint History**

- Pre 1860's: Whale Oil Refining
- 1860's-1960's: Petroleum Refining
  - 1890's: Standard Oil Refinery Consolidation (broken up in 1911)
- 1966: Refinery Operations Cease
- 1978: Seep into Newtown Creek Noted by U.S. Coast Guard and Remediation Begins.


Since the initial 1978 investigation, remediation has occurred and is active at the following Sites in Greenpoint:

# **BP Terminal** Remediation Update



#### **Brooklyn Terminal Operations**

 Active petroleum bulk storage facility

• 12 tanks for a total of 5.9 million gallons of storage



BP Terminal: Removal of the roof off the main product recovery storage tank to clean and perform the tank's 10 year inspection.

### **BP Terminal Order on Consent**

- Between 1986 and 1999, BP had petroleum releases totaling 124,973 gallons. The releases were contained or deemed recovered by the remediation system.
- In 2006 BP signed a consent order with the NYSDEC agreeing to continue to remediate the historic contamination on their property:

"BP agrees to continue to operate this [recovery] system... until the liquid phase free product that is currently at the Site is removed to levels that do not represent a threat to human health or the environment..."

STATE OF OPPORTUNITY

#### **Remediation Goals**

- Protect Public Health & Safety
- Recover Free Product
- Prevent Seepage to Newtown Creek
- Accelerate Soil Restoration
- Accelerate Ground Water Restoration
- Prevent Vapor Intrusion






### **BP** Terminal Remediation



- Onsite management: Antea Group
- Remediation Summary:
  - Product recovery
  - Groundwater treatment and discharge
  - Vapor monitoring




#### **Product Recovery System**



- 11 active product recovery wells
- Aboveground or subsurface vaults
- Dual phase wells pump both groundwater and free-product





#### **Groundwater Treatment System**

- SPDES Equivalency
- Components:
  - Oil/water separator
  - Bag filters
  - Air stripper
  - Carbon column



BP Terminal: Air stripper and bag filter units part of the BP groundwater treatment system.



## Vapor Monitoring



• Annual screening for methane across site

 Monthly indoor air sampling in occupied buildings.



# **Remedial Milestones**

• 2012


 Recovery wells RW-14 and MW-24 added

• 2013

- Groundwater treatment system
- 2014
  - Recovery well rehabilitation study
  - Air compressor system
- 2015
  - Interim wells OW-11 and MW-6

### Sale of Brooklyn Terminal

In October 2015, BP entered into an asset sale agreement with Kinder Morgan.

Includes the transfer and sale of 15 storage terminal properties (including the Brooklyn Terminal) and the creation of a joint venture LLC: KM Phoenix Holdings LLC.

Transfer date is February 1, 2016.



### What Does This Mean For Remediation?

- Consent Order amended to add Kinder Morgan
- New Project Manager: R.J. Sherman, P.G. Remediation Manager Kinder Morgan
- Antea Group will remain as the on-site consultant.
- Current operations and future goals remain consistent: progress will continue as planned.
